

OUT-OF-STATE VEHICLE PURCHASE POLICY

In an effort to provide our customers with a seamless process, we offer the following for those who live outside the state of Minnesota and wish to purchase a vehicle from us.

The customer agrees to sign the purchase paperwork and take "delivery" of vehicle within 72 hours of agreed upon terms. \$2,500 deposit is required and will secure the vehicle for 72 hours. This deposit will be forfeited as a restocking fee should the deal not be completed for any reason on behalf of the purchaser. In addition to the deposit, a vehicle will NOT be held for any reason without the following information:

- · Valid driver's license
- Valid insurance card
- Completed credit application (if applicable)
- Signed Privacy Notice and Export Policy if new vehicle
- Signed buyer's agreement with terms of sales outlined (this will be faxed or scanned, then emailed to you for your review)

"Delivery" is defined as either possession of vehicle taken or Maverick Signing process complete, along with full payment of vehicle. Two scenarios for "delivery" are as follows:

1	Fly into Minneapolis and take delivery of vehicle.

- Customer flys to Feldmann Imports via MSP or other airport. Customer is responsible for shipping vehicle or driving it home. Transportation cost is not included in deal.
- 2 Customer pays third party inspector to inspect the vehicle and uses Maverick signing for documents through our Finance Department.
 - Lemon Squad (1-888-231-7965) or any 3rd party you choose.
 - Inspection must be completed within 24 hours. Customer is responsible for scheduling inspection and payment. If not completed within 24 hours, vehicle will be released from hold.
 - Feldmann Imports will arrange notary services to complete document signing process. This service charge will be applied to the selling price.

Methods of payment accepted:

- Wire Transfer (wire must be cleared before vehicle will be released)
- Finance/Lease upon approved credit

²Customer is responsible for shipping or driving vehicle back to residence. Transportation cost is not included in the deal.

³Customer responsible for scheduling inspection and payment. For inspection, call Amy Hall (651) 262-4049/ahall235@hotmail.com or any 3rd party inspector. If vehicle is not inspected within 24 hours of deposit, vehicle will be released from hold.
